Animal Health Act, 2009

23.1 (13) Unless the order provides otherwise, a person affected by the order shall comply with it immediately after the order is published or the person receives notice of it under subsection (12), whichever is earlier. 2023, c. 2, Sched. 1, s. 2.

24(9) When an order is issued under this section and notice is provided in accordance with the requirements of this section, all persons in the animal health control area or affected by the order shall comply with the order and with the requirements of the Chief Veterinarian for Ontario under subsection (7) and, if requested to do so, shall provide proof of such compliance. 2009, c. 31, s. 24 (9)

Compliance

(11) A person who is subject to an order under this section shall comply with the order within the time period specified in the order and, if requested by the Chief Veterinarian for Ontario, shall provide proof of compliance. 2009, c. 31, s. 25 (11).

Food Safety and Quality Act, 2001

- 4 (1) No person shall carry on a licensed activity or operate a premises where a licensed activity is carried on unless the person holds a licence for the activity issued under this Act. 2001, c. 20, s. 4 (1).

Provision

Restrictions on transporting, and exceptions

13. (1) No person except a licensed collector shall transport regulated dead animals, cured compost or composting material on a public highway. O. Reg. 105/09, s. 13 (1).

Salvaging facilities

25. (1) No person shall operate any premises where salvaging facility licensed activities are carried on unless the person holds a licence to operate a salvaging facility. O. Reg. 105/09, s. 25 (1).

FSQA – O Reg 171/10 – Eggs and Processed Eggs

Provision

Sale of graded eggs only

4. (1) Subject to sections 5, 6 and 8, no person shall sell or distribute eggs or offer eggs for sale within Ontario unless the eggs have been graded, packed, marked and labelled at an egg-grading station in accordance with the Safe Food for Canadians Regulations (Canada). O. Reg. 171/10, s. 4 (1); O. Reg. 718/20, s. 2.

(4) No person shall pack, mark or label eggs in a manner intended to deceive a purchaser into believing that the eggs have been graded under the Safe Food for Canadians Regulations (Canada). O. Reg. 171/10, s. 4 (4); O. Reg. 718/20, s. 2

Shipping and transporting eggs, processed egg

9. (1) No person shall ship, transport or deliver eggs or processed egg in Ontario except for purposes of facilitating a sale authorized under this Regulation or as authorized under the Safe Food for Canadians Regulations (Canada). O. Reg. 171/10, s. 9 (1); O. Reg. 718/20, s. 5 (1).

FSQA - O Reg 31/05 - Meat

Provision

Operation

- 42. The operator of a meat plant shall ensure that it is operated and maintained in a manner that,
- (a) facilitates the hygienic operation of the plant, the hygienic slaughter of food animals and the hygienic processing, packaging, labelling, handling and storing of carcasses, parts of carcasses and meat products; and
- 45(2) The operator of a meat plant shall ensure that the facilities, equipment and utensils of the plant are maintained in a sanitary condition. O. Reg. 31/05, s. 45 (2).
- **50**. (1) The operator of a meat plant shall ensure that the facilities, equipment and utensils in the killing room or the rooms or areas of the plant where carcasses, parts of carcasses, meat products or ingredients are processed, packaged, labelled, stored or otherwise handled are, as often as is necessary to maintain a hygienic environment and to prevent the contamination of food, thoroughly cleaned with hot water and detergent, rinsed with potable water and sanitized. O. Reg. 31/05, s. 50 (1).
- 50. (3) The operator shall ensure that equipment, utensils and food contact surfaces that have been in contact with contaminated material are immediately and effectively cleaned and sanitized. O. Reg. 31/05, s. 50 (3).
- 50 (4) The operator shall ensure that the facilities, equipment and utensils mentioned in subsection (1) are effectively cleaned and sanitized at the end of each working day or, if there is more than one shift in a working day, at the end of each shift. O. Reg. 31/05, s. 50 (4).

FSQA - O Reg 465/19 - Fish Processing

- 41(2) The operator shall ensure that the cleaning and sanitizing procedures referred to in clause (1) (a) are performed in a way that minimizes the risk of contamination of the fish processing premises, equipment, utensils, fish products, ingredients, labelling materials and packaging materials.
- 42. (1) The operator of a fish processing operation in respect of which a licence is required under this Regulation shall ensure that the fish processing plant, equipment, utensils and food contact surfaces are cleaned and sanitized for the start of each working day.

42.(2) The operator shall ensure that the equipment, utensils and food contact surfaces that have become contaminated are effectively cleaned and sanitized in a way that minimizes the risk of contamination of fish products, ingredients, labelling materials and packaging materials.

Milk Act

Provision

13(2) No person shall hinder or obstruct an officer or field-person mentioned in subsection (1) in the course of his or her duties, furnish him or her with false information or refuse to furnish him or her with information. R.S.O. 1990, c. M.12, s. 13 (2).

Licence to operate plant

15 (1) No person shall operate a plant without a licence therefor from the Director.

Licence to operate as distributor

(2) No person shall carry on business as a distributor without a licence therefor from the Director.

Milk Act – Reg 761 – Milk and Milk Products

Provision

- 86. (1) Every operator of a plant shall ensure that the rooms, facilities, equipment and utensils used in areas of the plant where milk or milk products are handled, processed or stored are thoroughly cleaned and sanitized as often as necessary to maintain a hygienic environment and to prevent the contamination of the milk or milk products. O. Reg. 152/23, s. 6.
- 86(2) The operator shall ensure that the cleaning and sanitizing referred to in subsection (1) are performed in a way that maintains a hygienic environment and minimizes the risk of contamination of the milk and milk products. O. Reg. 152/23, s. 6.
- 87. (1) Every operator of a plant shall ensure that written sanitation procedures for the cleaning and sanitizing described in section 86 are developed, implemented and monitored and that they are updated as needed. O. Reg. 152/23, s. 6.
- (2) The written sanitation procedures shall include,
- (a) cleaning and sanitizing requirements for the rooms, facilities, equipment and utensils used in areas of the plant where milk or milk products are handled, processed or stored; and
- (b) cleaning and sanitizing schedules. O. Reg. 152/23, s. 6.
- (3) The operator shall ensure that on each day that a cleaning and sanitizing activity described in section 86 is performed, a record is created that includes,
- (a) the date the activity was performed;
- (b) the type of activity that was performed;
- (c) the person who performed the activity; and

- (d) the results of the activity. O. Reg. 152/23, s. 6.
- (4) The operator shall ensure that every record created under subsection (3) is kept for at least one year after the date it was created and that it is readily accessible. O. Reg. 152/23, s. 6.

Bees Act

Provision

- 4(8) No person shall obstruct the Provincial Apiarist, Assistant Provincial Apiarist or an inspector in the performance of their duties or furnish them with false information. R.S.O. 1990, c. B.6, s. 4 (8).
- **5** (1) Where an inspector has reasonable grounds for believing that any pest is present or disease exists in any bees or that any beekeeping equipment is infected, the inspector may, by order in writing,
- (a) require the beekeeper to treat or disinfect such bees or beekeeping equipment in such manner and within such period as the order requires;
- (b) require the beekeeper to destroy by fire, or other means approved by the Provincial Apiarist, within such period as the order requires, such bees or beekeeping equipment as in the opinion of the inspector cannot be suitably treated or disinfected; or
- (c) require the beekeeper to retain the bees and beekeeping equipment at such location and for such period of time as the order requires. R.S.O. 1990, c. B.6, s. 5 (1).

Location of hives

19 (1) No person shall place hives or leave hives containing bees within 30 metres of a property line separating the land on which the hives are placed or left from land occupied as a dwelling or used for a community center, public park or other place of public assembly or recreation. 2002, c. 17, Sched. F, Table.

Location near highway

(2) No person shall place hives or leave hives containing bees within 10 metres of a highway. 2002, c. 17, Sched. F, Table.

Inspection orders

(3) An inspector who finds hives containing bees in a location contrary to subsection (1) or (2) may order that those hives be relocated to a location that is in compliance with subsection (1) or (2). 2002, c. 17, Sched. F, Table.

Certificate of registration

21 (1) No person shall be a beekeeper in Ontario without a certificate of registration issued by the Provincial Apiarist. R.S.O. 1990, c. B.6, s. 21 (1).

Livestock Community Sales Act

URL: Livestock Community Sales Act, R.S.O. 1990, c. L.22 (ontario.ca)

Provision

Licence

- 3 No person shall engage in the business of operating community sales without a licence therefor from the Director. R.S.O. 1990, c. L.22, s. 3.
- S. 17. No person shall hinder or obstruct the Director or an inspector in the course of his or her duties, or refuse to permit him or her to inspect any premises or any truck or other conveyance thereon or any livestock therein, or furnish him or her with false information, or refuse to furnish him or her with information. R.S.O. 1990, c. L.22, s. 17.

Livestock Community Sales Act – Regulation 729 – General

Provision

- 11(2) Where an inspector directs that livestock be detained as provided in subsection (1), the operator shall,
- (a) segregate in a secure place the detained livestock from other livestock being offered for sale; and
- (b) hold the detained livestock in segregation until it is examined by an inspector who is a veterinarian. R.R.O. 1990, Reg. 729, s. 11 (2).

Agricultural Tile Drainage Installation Act

Provision

2 (1) No person shall carry on the business of installing a drainage work unless the person is the holder of a licence for such purpose from the Director. R.S.O. 1990, c. A.14, s. 2 (1).

Idem

(2) No person shall be the operator of a machine used in installing a drainage work unless he or she is the holder of a licence for such purpose from the Director. R.S.O. 1990, c. A.14, s. 2 (2).

Idem

(3) No person shall use, or permit or cause to be used, in installing a drainage work a machine unless the owner of the machine has obtained a licence therefor from the Director and the licence is attached to and exposed on the machine. R.S.O. 1990, c. A.14, s. 2 (3).
