	The frequency of fire drills for school-based, licensed child care centres that provide care for children who are four years of age and older, is not aligned with the fire drill frequency for schools.		
RATIONALE FOR CHANGE	Some schools open for summer school sessions and it is important that fire drills continue to be held if this occurs.		
	Fire drills in school-based, licensed child care centres that provide care for children who are four years of age and older may be scheduled at the same frequency as those of the school in which they are based. This may result in one less fire drill per school season, however, it is felt that this would not adversely affect fire safety in the circumstances.		
IMPACT	This change will assist school-based, licensed child care operators with establishing fire drill schedules and if necessary, synchronizing these schedules with those of the host school.
