Notice – Approved Forms

Effective Date: This Notice is to be effective the date that sections 42, 58, 85 and 104 and subsection 126 (1) of Schedule 6, section 73 of Schedule 7 and section 55 of Schedule 8 to the Cutting Unnecessary Red Tape Act, 2017, comes into force.

4. Corporations Act

6. Extra-Provincial Corporations Act

The following forms shall be in the form approved by the Director:

- 2. An appointment of an agent for service or a revised appointment of an agent for service.
- 3. An application for an amendment to an extra-provincial licence.
- 4. An application for termination of an extra-provincial licence.

7. Limited Partnerships Act

A declaration, a declaration of change and a declaration of dissolution or withdrawal must be in a form approved by the Registrar.

8. Not-for-Profit Corporations Act, 2010

The following forms shall be in the form approved by the Director:

- 7. An application for authorization to continue in another jurisdiction under section 116 of the Act.
- 8. An application under section 117 of the Act for authorization to continue as a cooperative corporation under the Co-operative Corporations Act.
- 9. Articles of arrangement under section 120 of the Act.
- 10. Articles of reorganization under section 119 of the Act.
- 11. Articles of dissolution under section 167 of the Act.
