## **ONTARIO REGULATION**

to be made under the

## FOOD SAFETY AND QUALITY ACT, 2001

Amending O. Reg. 171/10

(EGGS AND PROCESSED EGG)

- 1. (1) The definitions of "egg-grading station" and "egg-processing station" in subsection 1 (1) of Ontario Regulation 171/10 are revoked and the following substituted:
- "egg-grading station" means an establishment where eggs are graded by a licence holder under the *Safe Food for Canadians Act* (Canada);
- "egg-processing station" means an establishment where eggs are processed and treated by a licence holder under the *Safe Food for Canadians Act* (Canada);
- (2) The definitions of "Federal Egg Regulation" and "Federal Processed Egg Regulation" in subsection 1 (1) of the Regulation are revoked.
- (3) Clause (a) of the definition of "inedible egg" in subsection 1 (1) of the Regulation is revoked and the following substituted:
  - (a) the egg being contaminated, within the meaning of that term in the *Safe Food for Canadians Regulations* (Canada),
- (4) The definitions of "inedible processed egg" and "processed egg" in subsection 1 (1) of the Regulation are revoked and the following substituted:
- "inedible processed egg" means processed egg that contains some inedible egg or that is otherwise not suitable for human consumption;

- "processed egg" means processed egg product as defined in the *Safe Food for Canadians Regulations* (Canada);
- (5) The definition of "reject egg" in subsection 1 (1) of the Regulation is amended by striking out "Federal Egg Regulation" at the end and substituting "Canadian Grade Compendium, a document prepared by the Canadian Food Inspection Agency and published on a website maintained by the Agency, as that document is amended from time to time".
- (6) The definition of "ungraded eggs" in subsection 1 (1) of the Regulation is amended by striking out "Federal Egg Regulation" at the end and substituting "Safe Food for Canadians Regulations (Canada)".
- 2. Subsections 4 (1), (3) and (4) of the Regulation are amended by striking out "Federal Egg Regulation" wherever it appears and substituting in each case "Safe Food for Canadians Regulations (Canada)".
- 3. Section 7 of the Regulation is amended striking out "Federal Processed Egg Regulation" at the end and substituting "Safe Food for Canadians Regulations (Canada)".
- 4. Paragraph 3 of subsection 8 (1) of the Regulation is revoked and the following substituted:
  - 3. Eggs from a hen that has been slaughtered.
- 5. (1) Subsection 9 (1) of the Regulation is amended by striking out "Federal Egg Regulation or the Federal Processed Egg Regulation" at the end and substituting "Safe Food for Canadians Regulations (Canada)".
  - (2) Subsections 9 (4), (5) and (6) of the Regulation are revoked.
  - 6. The Regulation is amended by adding the following French version:
